This change in policy could create new revenues for Title IV-E agencies that currently pay the placing agencies for bed days when a child is AWOL, hospitalized or on leave because agencies will be able to seek reimbursement if the agency incurs the costs for children that are AWOL, hospitalized or on leave if the leave does not exceed 14 days and the child returns to the same placement. The source for this allowable costs comes from the child welfare policy manual, section 8.1B and the Social Security Act, section 472.
