This rule outlines the uniform statewide standards for foster care maintenance (FCM) minimum and maximum reimbursement amounts for public foster homes, relative homes licensed as foster homes and pre-finalized adoptive homes that continue to receive Title IV-E FCM reimbursements that have been established by the Ohio Department of Job and Family Services. Changes include removing the word "payment" and replacing it with the word "reimbursement." The use of the JFS 01659 is no longer available due to statewide automated system.
