This rule sets forth the foster care maintenance reimbursement requirements related to the difficulty of care needs of a child placed in a foster home, relative home, or pre-finalized adoptive home. The word "payment" was replaced with the word "reimbursement" throughout this rule to clarify that foster care maintenance is not a payment but rather a reimbursement to Title IV-E agencies for services they have provided to a child eligible for foster care maintenance.
