reimbursability redeterminations. Changes were made to this rule to identify that foster care maintenance eligibility redeterminatons will be completed in the statewide automated child welfare informtion system (SACWIS) instead of using the current electronic version of the redetermination form (JFS 01452A) once SACWIS is implemented in each Title IV-E agency. New language has been added to allow reimbursement for a child while on a trail home visit, if the visit does not exceed 14 days in a month, and the child's placement continues with the same provider.
