As part of the Family First Prevention Services Act of 2018 (H.R. 1892), a residential treatment facilities certified after October 1, 2020 must meet be certified as a Qualified Residential Treatment Program (QRTP). Agencies certified to operate a residential facility prior to October 1, 2020 have until 2024 to meet the QRTP requirements. The proposed rule added the requirements for a QRTP certified after October 1, 2020.

The rule outlines the cost report "Agreed Upon Procedures" engagement for each agency that files a cost report. The Agreed Upon Procedure engagement must be done annually by a certified public accountant. This rule has been amended to include a QRTP.
