OAC rule 5101:2-48-09, entitled "Application process and preservice training" gives agencies guidance regarding the process and training required for persons seeking adoption approval. Paragraphs (A) and (B) were updated for clarification purposes. Paragraph (F) was updated to better align with foster care requirements. Paragraph (H) was removed as it was unnecessary due to the requirement in (G). The new paragraph (I) was updated to remove a requirement that ODJFS is responsible to perform. The new paragraph (N) was updated to align adoption and foster care training requirements. Foster care training rule revisions will be forthcoming. All other changes were the result of discussion and review of the Partners for Ohio's Families (PFOF) rule review.
