This rule is proposed for amendment to implement section 5103.18 of Sub. Senate Bill 163 of the 127th General Assembly.

This rule outlines the requirements for completing an update or amendment to an adoptive homestudy. This rule is proposed for amendment to clarify when homestudy updates are due; exempt international-only adoptions from using the JFS 01385 "Ohio Department of Job and Family Services Assessment for Child Placement Update;" clarify what documents must be completed and attached to the JFS 01385; and mandate use of the JFS 01200 "Fire Inspection Report for Foster Homes or Residential Facilities Certified/Approved by ODJFS" for a fire inspection of a prospective adoptive parent's home. This rule was also amended to include the new requirements for BCII criminal background checks, the process for criminal background checks at the time of update, and a timeframe for completion of criminal background checks for new adult household members. Final revisions to this rule include a timeframe for completion of the JFS 01653 "Medical Statement for Foster Care/Adoptive Applicant and All Household Members" for new household members.

This rule is being revised to identify who is able to sign the JFS 01653 (Medical Statement) in (I)(1). A physician assistant, clinical nurse specialist, certified nurse practitioner or certified nurse-midwife have been added. In (I)(2) a statement was added that the personal reference shall not be completed by a relative. In (I)(3)language was added to allow the agency to determine if a physical, psychiatric or psychological report is required to ensure the safety of the child. Paragraphs (J) and (K) were revised to require that any homestudy that was approved prior to the date of this rule and has a BCII check that is greater than four years must have a new BCII check completed within sixty days of the effective date of this rule. Paragraphs (P), (Q) and (R) were revised to add a timeframe in which an adoptive parent must notify the agency of specific events that happen to their adoptive child or events within the home. In Paragraph (R)(4) language was added to require that a JFS 01653 be completed on a new child household member who is not a foster child. Language was added to require a household member who turns 18 have a BCII check within ten working days of his 18th birthday. The word "approved" was removed from paragraph (R)(8). The word "significant" was added to (R)(9) in terms of a change in financial status or income.
