- 6. What are the reasons for proposing the rule?

This rule is proposed for amendment due to the Family First Prevention Services Act and as a result of the passage of HB 166 of the 133rd General Assembly.

7. Summarize the rule's content, and if this is an amended rule, also summarize the rule's changes.

This rule provides guidance to agencies on the homestudy process for prospective adoptive applicants. Paragraphs (Q)(1), (Q)(8) and (Q)(11) were amended regarding interviews, physical exams and references for prospective adoptive applicants and their adult household members. Paragraph (Q)(3)(b) was amended to provide reference to the offense list in appendix A to rule 5101:2-7-02. (Q)(6) was added as a new paragraph to require a search of the national sex offender registry for adoptive applicants and adult household members. New paragraphs, (Q)(15) and (Q)(16), were added to require smoke alarms and carbon monoxide detectors in the adoptive applicant's home. Paragraph changes were amended due to legislative changes in the Family First Prevention Services Act and to keep alignment with foster care requirements. Remove from paragraph (W) information about submitting the JFS 01318 "SACWIS Private Agency Provider Request" since private agencies have provider access to enter homestudies in SACWIS. Form revision dates were removed throughout the rule.

There are multiple requirements that would result in a cost to an agency simply by the time involved for an employee to assess an adoptive parent applicant. The report (homestudy) is required to be completed by an assessor who must evaluate the home for compliance for approval which includes things such as criminal background checks, medical evaluations, safety audits and financial stability.
