OAC 5101:2-48-12 entitled Completion of the Adoption Homestudy provides guidance to agencies on the homestudy process for prospective adoptive applicants. Paragraph (E)(4) was added to provide reference to the new sections Ohio Revised Code 2131.03, 2131.031, 2131.032, 2131.033 and 2131.034 which were created to address persons with disabilities and modifications that may be necessary to accommodate them when applying as an adoptive parent. Paragraph (D) corrected spelling of word 'conflict'.
