This rule contains the requirements for the information about a child that is to be disclosed to adoptive families. This rule includes Senate Bill 27 information disclosure requirements and a requirement regarding the use of the new "Adoption Information Disclosure Form." The rule requires that all identifying information regarding the child's birth family be removed from the Child Study Inventory, regardless of whether the adoption is by a relative or foster care provider. New language requires public and private entities which place for adoption a child who is found to be an adjudicated delinquent for committing specified criminal acts to inform the prospective adoptive parents about the child's social history, history of delinquent and violent acts, and mental and emotional evaluations prior to the adoptive placement.
