This rule outlines the process for releasing a homestudy and related information by a PCPA, PCSA or PNA to another agency and to adoptive applicants, specifically

as it meets the requirements of a federal corrective action plan. It is replacing a rule of the same number with the following changes: a requirement that agencies may not solicit homestudies to locate a same race placement unless specific procedures are followed and a requirement is being made on how agencies must file and maintain homestudies obtained from other agencies.

Paragraph (F) - clarified that information requested from another agency for the purpose of receiving a completed homestudy must be in accordance with Chapter 5101:2-48 of the Administrative Code.
