5101:2-49-08

Allowable services for refugees.

- (A) RRP social services are services described in 45 CFR 400.154 and 400.155 and supported by grants awarded to the Ohio department of human services (ODHS) by the office of refugee resettlement (ORR). Family support administration, department of health and human services.
- (B) The following RRP social services may be provided by the CDHS or purchased under contract from a provider of social services:
- (1) Outreach services, including activities designed to familiarize refugees with available services.
 - (2) Day-care services, when necessary for participation in services other than employability services. The child care may be provided by certified day-care home providers, certified day-care in-own-home providers, or by a licensed type A day-care home or by a licensed day-care center. All child care providers must be in compliance with Chapter 1504. of the Revised Code, and Chapters 5101:2-12, 5101:2-13, 5101:2-14, and 5101:2-15 of the Administrative Code, as applicable.
 - (3) Emergency services, including assessment and short-term counseling to persons in a perceived crisis; referral to appropriate resources and making arrangements for necessary services.
 - (4) Translation and interpreter service, when necessary for a purpose other than in connection with employment or participation in employability services; includes collateral contacts on behalf of the client.
 - (5) Employability services, including the following activities:
 - (a) Individual employment services, including development of an employability plan, job development, referral to job opportunities, job search and job placement and follow-up.
 - (b) Group employment services, including world-of-work and job orientation, job clubs and training in job search techniques.
 - (c) Employability assessment services, including aptitude and skills testing.
 - (d) English language instruction, with an emphasis on English as it relates to

obtaining and retaining a job. Courses may include survival English as a second language (ESL), employment-related ESL or vocational English as a second language (VESL).

- (e) Employment-related day care, when necessary for participation in employment services or for the acceptance or retention of employment. Employment-related day care must meet the same standards specified for nonemployment day care in paragraph (B)(2) of this rule.
 - (f) Employment-related transportation, when necessary for participation in an employability service.
 - (g) Employment-related translation and interpreter services, when necessary in connection with employment or participation in an employment service.
- (6) Health-related services including information and referral to appropriate resources; assistance in scheduling appointments and obtaining services; counseling to individuals or families to help them understand and identify their physical and mental health needs and maintain or improve their physical or mental health; assistance in completing health-screening procedures as required by the Ohio department of health.
- (7) Transportation services, when necessary, for a client's participation in a service other than an employability service.
- (8)
 - (a) Vocational training, including classroom training; professional refresher training or other professional recertification services; and driver education when it is part of a CDHS-approved employability plan.
 - (b) Vocational training and skills recertification training are limited to one year's duration.
- (C) Standard RRP service codes, billing units and descriptions are in appendix A of this rule.
