This rule provides guidance for agencies who wish to apply to become a certified

foster care agency. Paragraph A was amended to require the application to be submitted electronically. The paragraph was also amended to extend the requirement to submit the application from ninety days to one-hundred twenty days from the intended date of start-up. The rule was also amended for clarity.
