Paragraphs (A), (K) and (N) were amended to include a reference to section 2151.86 of the Revised Code in regard to the conducting of criminal records checks. In paragraph (R), changed the reference from division (C)(1) of section 2151.86 of the Revised Code, to reference paragraph (J) of rule 5101:2-7-02 of the Administrative Code.
