This rule sets forth personnel requirements for agencies certified by ODJFS and for

public agencies. The current rule includes a list of prohibited crimes for agency employees. The proposed amendments add aggravated arson and arson to the list of prohibited crimes for agency employees and clarify that the rule does not apply to foster caregivers.
