This rule is proposed for amendment due to the five year review and the passage of HB 166 of the 133rd General Assembly.

This rule provides guidance on the procedure for requesting a waiver of foster care rules. Paragraph (A)(1) was removed due to a legislative change which eliminated that specific language. Paragraph (E) was removed as all agencies now have access to the SACWIS system.
