This rule is proposed for amendment to implement section 5103.18 of Sub. Senate Bill 163 of the 127th General Assembly.

This rule sets forth an agency's responsibility for an initial application for child placement. This rule was amended to require a foster care applicant to provide the name of any other agency with which the applicant was previously certified. The rule was also amended to require the completion of the JFS form 01200 "Fire Inspection Report for Residential Facilities Certified by ODJFS" for foster homes prior to certification.

Paragraph (I) was revised to clarify what an agency must review along with the required financial statement for a foster care applicant.

Paragraphs (N) and (O) were revised to require a safety audit of a foster home as well as a fire safety inspection.

7/2/08 Paragraph (F)(3) was revised to clarify the exclusions for the summary report of abuse and neglect.
