This rule addresses preplacement and continuing training requirements for foster caregivers. Consistent with HB 117, the proposed amendments remove CPR and first aid training from preplacement training for pre-adoptive infant foster homes and family foster homes; require continuing training to be conducted based on the two year certification period rather than annually; remove continuing training topics from the rule to allow agencies to base the continuing training on a training needs assessment rather than on the list of topics previously required by law; clarify when continuing training may be completed outside of a classroom setting; clarify when agencies may waive continuing training requirements; allow agencies to waive training when a foster caregiver is serving on acitve U.S. military duty outside of Ohio.
