Paragraph (C) was amended for clarity and to add a training requirement for the reasonable and prudent parenting standard. Paragraph (F)(3) was amended to allow up to six hours of outside the classroom training to be accepted for pre-placement training. Paragraph (G)(2) was amended to include training for the caregiver that relates to providing independent living services as part of the written needs assessment and continuing training plan.
