This rule is being proposed for amendment to implement sections 5103.0312, 5103.032 and 5103.035 of Am. Sub. House Bill 214 of the 127th General Assembly.

This rule sets forth the training requirements for a person seeking to become certified to operate a family foster home or to maintain his or her foster home certification. Included in the rule is an increase in preplacement training hours from a minimum of twenty-four hours to thirty-six hours and a provision of reimbursement for attending a preplacement training program and for attending a continuing training program.

The rule allows a foster caregiver to receive up to twenty percent of the required amount of continuing training by teaching one or more training classes to other foster caregivers or by providing mentorship services to other foster caregivers. The rule also defines "mentoring services" and outlines the criteria by which the foster caregiver is considered to be qualified to provide the teaching and mentoring services.

The rule further requires the public children services agency (PCSA), private child placing agency (PCPA) and private non-custodial (PNA) agency to specify the number of hours of continuing training, if any, the foster caregiver may complete by teaching one or more training classes to other foster caregivers or by providing mentoring services to other foster caregivers.

Foster caregivers will be reimbursed for their increased time spent in preplacement training and continuing training programs. Although PCSAs, PCPAs and PNAs will incur upfront costs by reimbursing the foster caregiver for attending the preplacement training and continuing training programs, ODJFS will reimburse the agency for costs incurred up to the minimum amount of training hours required by rule 5101:2-5-33 of the Administrative Code.
