This rule is being proposed for amendment to implement section 5103.0312 of Am. Sub. House Bill 214 of the 127th General Assembly. It is also being proposed for amendment as a result of the Five Year Review.

This rule sets forth the criteria by which a foster caregiver shall be reimbursed for preplacement training and continuing training. The foster caregiver shall be reimbursed in a lump sum for attending a preplacement training program. This rule also provides an additional provision under which the recommending agency may decline to make a stipend payment to a foster caregiver. In addition, the rule clarifies how the Ohio Department of Job and Family Services (ODJFS) will reimburse the recommending agency for preplacement training completed by the foster caregiver.

This rule removes all language which references the stipend payment rate payable to foster caregivers and the training allowance payment for training rendered between January 1, 2001 and December 31, 2003. The rule also removes language related to the computation of preplacement and continuing training hours that will qualify for stipend reimbursements.

Foster caregivers will be reimbursed for their increased time spent in preplacement training and continuing training programs. Although PCSAs, PCPAs and PNAs will incur upfront costs by reimbursing the foster caregiver for attending the preplacement training and continuing training programs, ODJFS will reimburse the agency for costs incurred up to the minimum amount of training hours required by rule 5101:2-5-33 of the Administrative Code.
