To implement the provisions of HB 117 of the 125th General Assembly.

The rule sets forth program requirements for private agencies operating preplacement or continuing foster caregiver training programs. Consistent with HB 117, the proposed amendments would clarify when training proposals are required to be sent to ODJFS for approval; change training requirements; clarify the circumstances when an agency or the Ohio child welfare training program can condition enrollment of a foster caregiver in a training program; allow the payment of a fee for a foster caregiver to attend a training program operated by another agency or by the Ohio child welfare training program; clarify that an agency can contract with an individual or a public or private entity to operate a training program; clarify that a PCSA is not required to submit a training proposal to ODJFS for approval.
