Paragraph (C) was amended to replace "agency director" with "agency administrator or designee." Paragraph (D) was amended for clarity. Paragraph (G) was amended for clarity. Paragraphs (H), (J) and (L) were amended to reference the required training topics described in rule 5101:2-5-33. Paragraph (O) was amended for clarity.
