This rule sets forth the requirement of a private child placing agency (PCPA) and a private non-custodial agency (PNA) to develop and submit a training proposal to the Ohio Department of Job and Family Services (ODJFS).

This rule adds language to address the approval process when a training proposal is submitted by a consortium. This rule also clarifies the timeframe for submitting the training proposal to ODJFS and clarifies the timeframe for an approved training proposal's validation date. An additional training course which the PCPA or PNA may offer as appropriate to the training needs of the foster caregiver who will receive training through the program was also added to this rule.
