This rule describes the responsibilities of the public children services agencies (PCSAs) and private child placing agencies (PCPAs) when a temporary agreement for temporary custody of an Indian child has been requested by a parent or custodian. The rule has been reorganized to provide clarity.

There are no fines or civil penalties for non-compliance with this rule other than the forfeiture of certification through denial or revocation.

This rule requires the agency to notify the tribe's designated agent or tribal court when the Indian child's parent, guardian or Indian custodian enters into a voluntary placement agreement for temporary custody of the child with the agency. This rule also requires the agency to obtain documentation for the case record.
