The Ohio Department of Job and Family Services was allocated funds in House Bill 166 to be used for youth currently in the custody of a Public Children Services Agency (PCSA) or to prevent youth from entering into the custody of a PCSA by custody relinquishment for the sole purpose of the child obtaining access to needed treatment. This rule established funding transfers and allocations. This rule establishes initiatives to prevent children from entering custody or to support those already in custody by state level programming, Family and Children First Council shared service and sustainability planning, training and technical assistance, and PCSA relinquishment support. Due to the COVID-19 pandemic, budgetary changes were made. This rule reflects those changes by noting which funds occurred solely in SFY 2020 to those solely in SFY 2021. In addition, Multi-System Youth Funds were allowed to be used for emancipating youth during the COVID-19 pandemic.
