This rule sets forth the requirements for initial applications for foster home certificates. Language was added that brings this rule in compliance with SB238 and makes the rule applicable to applicants for foster care. The rule as it exists covers general requirements for foster caregivers. The rule is applicable to individuals who are already certified to provide foster care. Language was added to clarify that these requirements apply to applicants as well as to existing foster care providers. Language was also added to paragraph (F) concerning who is authorized to complete the JFS 01653 "Medical Statement for Foster Care/Adoptive Applicant and All Household Members".
