This rule provides guidance to foster caregivers on the proper safety items and procedures in a foster home. Paragraph (I) was amended to clarify that storage areas where a child might be confined must be large enough to walk in. Paragraph (Q) was amended to state that all unvented heaters that burn kerosene, gas or oil shall not be used. A new paragraph (W) was added to state that all prescription drugs in a foster home must be stored in a locked cabinet or storage area except that an inhaler or medication may be left unlocked if a person has a special health condition that requires the inhaler or medication to be immediately available.
