This rule is proposed for amendment as a result of the five year review.

This rule provides guidance for children placed in residential facilities for fire safety issues. Paragraph (A)(1) was amended from ninety days to six months for a facility to obtain a fire inspection. Paragraph (B) was amended to require a fire inspection upon recertification of a facility. Paragraph (I) was amended to require the facility to maintain portable heaters in accordance with manufacturer's instructions.
