This rule is proposed for amendment as a result of the five year review.

This rule provides guidance to residential facilities on documenting and reporting critical incidents of children in the facility. Paragraph (A)(3) was amended to require notification of any serious injury or illness involving initial non-routine medical treatment. Paragraph (A)(8) and (9) were added to require notification for any incident of alleged abuse or neglect and any involvement with law enforcement.
