This rule describes Medicaid consumer liability and tells provider's that OODJFS'

payment for services is considered payment in full and they may not charge the consumer for any additional payments.

Changes include removing the exception statement from paragraph (C) of this rule that exempted long term care nursing facility consumers. Long term care nursing facilities and the Medicaid consumers of these facilities are now covered under this rule.
