Codes which are eligible for an ASC provider to bill have been updated to show any revisions to ASC groups and effective date of any ASC changes. Also the professional/technical indicator has been revised for certain laboratory codes and the preoperative day indicator in the "Visit column" has been revised to coincide with indicators in the CPT book for services which include the surgical procedure only(indicated by an * in the CPT book).
