This rule is being proposed due to the implementation of the new Medicaid Information Technology System (MITS) implementation.

This rule sets forth Medicaid coverage and reimbursement for all professional services. This rule is being amended to clarify existing language and to remove references to rescinded rules. To give providers additional information about place-of-service restrictions and applicability of the professional and technical modifiers, a new "Professional Component and Technical Component (PCTC) indicator" column has been created in Appendix DD to the rule. Appendix DD has also been updated to reflect reimbursement and coverage changes. The reimbursement amounts for 12 Current Procedural Terminology (CPT) codes have been reduced to comply with the mandated Medicaid payment ceiling of not paying more than the Medicare fee schedule. The reimbursement amount for two CPT codes has been increased to reflect changes in cost to physicians. Twenty-nine codes have been changed to "Not Covered" (NC) to reflect the requirement that only valid, HIPAA-compliant codes as determined by the American Medical Association and the Centers for Medicare and Medicaid Services may be covered. Reimbursement amounts have been assigned to two codes previously listed as "By Report." Coverage and reimbursement will begin for two new codes, A4466 and E2377. The annual fiscal impact of these changes will be approximately \$312.819.56.

Six additional codes (J0530, J0540, J0550, J0835, J7322, J9170) are being changed to NC (not covered)in Appendix DD to reflect that they are no longer valid codes within the Healthcare Common Procedure Coding System (HCPCS).

The follow-up days ("F/U Days") column of Appendix DD is being changed to reflect MITS configuration decisions.

The indicators of "6" and "8" are being removed from the "PCTC Indicator" column of Appendix DD because they do not provide additional information about place-of-of service restrictions or the applicability of the professional technical modifiers.

None of these revisions will have a financial impact.

It is estimated the deletion of no longer valid Durable Medical Equipment (DME) codes and the addition of a replacement DME code, price decreases for seven lab codes and eight DME codes, a price increase for a physician administered drug will increase expenditures for the remainder of the biennium by \$156,409.78. (b) New Equipment or Other Capital Costs

(c) Operating Costs

Implementation of the rule is not expected to have any significant cost to the Ohio Department of Job and Family Services, but any costs that may exist have already been budgeted and are reimbursed at 90% federal financial participation.

To the extent that a provider is a school district, county, township, or municipal corporation and the provider incurs a cost associated with requirements imposed by the proposed rule related to MITS implementation, the provider ideally will have budgeted for potentially increased costs. Moreover, providers may realize a savings related to increased efficiencies as a result of MITS implementation.

There will be a positive economic impact on companies that will assist providers in submitting claims electronically to ODJFS. The economic impact on providers to the extent that a provider is a school district, county, township, or municipal corporation cannot be estimated as some providers will realize cost savings related to increased efficiencies, while others may realize a loss in revenue related to claims denying that once paid as a result of improving the claims adjudication system to mirror existing payment policy.
