The "current price" that will be effective 9/1/05 is being revised for two codes for epoetin, a drug used for end-stage renal disease (ESRD) patients. The current price, on page 338 of the appendix, is being increased to \$9.76 for Q4055 and to \$3.05 for Q4054. These prices are the current Medicare prices. With this revised filing, question 13 on the RSFA has been revised to show that the net fiscal savings will be reduced by \$181,000 from \$5,122,242 to \$4,941,242.

ODJFS estimates that the proposed changes will result in a net fiscal savings of approximately \$4,941,242 for the biennium in effect when this rule is effective on 9/1/05. This figure includes the difference between the proposed savings resulting in the modification of the physician program codes (\$1,859,676) and the J, Q and 90371-90747 codes (\$3,819,000) in the pharmacy program as well as the increased expenditures expected and reflected on the RSFA submitted with the proposed new hearing aid rule 5101:3-10-11 (-\$737,434) to be effective 09/01/05.
