The activation of HCPCS code K0730 (Controlled dose inhalation drug delivery system) is estimated to increase the cost of the durable medical equipment (DME) program by approximately \$12,000 for the remainder of the current biennium. The remainder of the DME HCPCS code adjustments in this filing are estimated to have no direct effect for the agency during the current biennium due to the fact that these services are already being paid through the use of miscellaneous supply codes.
