This rule is being amended to reflect changes in coding due to new and revised codes for the Medicaid oxygen program and to remind providers of the existing requirement to be compliant with Home Medical Equipment (HME) licensure provisions of Chapter 4752. of the Revised Code.

7. If the rule is an AMENDMENT, then summarize the changes and the content of the proposed rule; If the rule type is RESCISSION, NEW or NO CHANGE, then summarize the content of the rule:

This rule sets forth the provisions for the HME supply list for the Medicaid program.

The intent of the amendments is not to change what is covered, but to replace several local-level oxygen codes with Health Insurance Portability and Accountability Act of 1996(HIPAA)compliant codes in the appendix of this rule. In addition, a sentence is added to the beginning of the rule body to remind providers of the existing requirement to be compliant with the HME licensure provisions of Chapter 4752. of the Revised Code administered by the Ohio Respiratory Care Board.

The rule appendix is being revised in order to address stakeholder requests to remove the need for prior authorization requirements for the supply of the following nutritional infusion and ostomy care supplies: B4220 parenteral supply kit, B4222 parenteral supply kit, B4244 parenteral supply (page 11), A4376 ostomy pouch, A4380 ostomy pouch, A4382 ostomy pouch, and A4383 ostomy pouch (page 7). In addition, supply code E1353 (page 16), oxygen regulator, is being removed from the supply list due to the implementation of the new oxygen rules 5101:3-10-13 and 5101:3-10-13.1. E1353 is now considered an inclusive item and is reimbursed as part of the rental price for any oxygen system paid for by the medicaid department.

The appendix of this rule (page 16) is being revised and notated due to stakeholder request and to allow sufficient time for providers to establish revised billing practices for oxygen services, the following HCPCS codes will be valid for dates of service prior to 11/1/07, afterwards these codes will no longer be valid for reimbursement thru the Ohio medicaid program.
