This rule is being proposed because of the five-year review and in order to make coding revisions to the appendix of this rule for certain medical supplies, in response to stakeholder input.

This rule sets forth the durable medical equipment and supplies covered by the Medicaid program. Changes to the rule include the addition of Healthcare Common Procedure Coding System (HCPCS) codes for elastic supports to the appendix of this rule in response to stakeholder input that these items should not be subject to licensure requirements currently administered by the Ohio Board of Orthotics, Prosthetics and Pedorthics (BOPP). In addition, updated prior authorization information for both oxygen and nebulizer codes has been added to the appendix of this rule, which details specific diagnoses that must be present in order for a Medicaid consumer to be eligible for these services without the need for a prior authorization.
