This rule is being proposed to establish new policy language in the durable medical equipment chapter of Medicaid.

This rule specifies coverage criteria for pneumatic compression devices and

accessories for consumers of Ohio Medicaid. The program currently provides for the use of pneumatic compression devices; however, prior to this rule, utilization and coverage criteria for these devices had not been established.

The department estimates that the administrative costs associated by providers of these services may be increased due to the requirement to complete and submit specific medical necessity documentation to the department for prior authorization of pneumatic compression devices. However, as these costs are provider specific and dependent on any particular providers current administrative costs, the overall impact on providers cannot be determined by the department at this time.
