This rule specifies that prior authorization is required before the department will allow reimbursement for the rental or purchase of certain durable medical

equipment (DME) items. The rule outlines the information requested on a prior authorization form, additional documentation that must accompany a prior authorization form, and the service limitations of an approved prior authorization request. Changes include allowing the department to consider evidence of malicious damage to or neglect of DME when the department evaluates prior authorization requests for replacement DME; requiring providers to maintain proof of DME delivery documentation on file; adding restrictions for DME substitutions; and requiring providers to submit a fully completed certificate of medical necessity.
