This rule is being proposed for adoption to update the HIPAA compliant billing codes and to change reimbursement rates. It replaces part of former rule 5101:3-1-07, 5101:3-12-10.

This rule sets forth the new HIPAA compliant billing code and sets forth the rates for private duty nursing services. The first hour of private duty nursing is being reduced by eight percent and each subsequent hour of private duty nursing is being reduced by five percent.

The calculation for Private duty nursing decrease in expenditures was included in the \$8,000,000. in Medicaid expenditure savings over the next biennium, with the Ohio Home Care Redesign calculations rules 5101:3-45-06, 5101:3-47-06, 5101:3-50-06. The reimbursement rate for private duty nursing has been decreased to eight percent of the first hour and five percent of the subsequent hours.
