Chapter 5101:3-13 of the Administrative Code is being re-organized as part of the five year rule review process. This re-organization will coordinate the review cycle for all rules within the Chapter and simplify future reviews. New rule 5101:3-13-01.1 replaces, all or in part, rules 5101:3-13-01, 5101:3-13-03, 5101:3-13-04, and 5101:1-13-05. This new rule is proposed as part of the five year rule review requirements.
