Chapter 5101:3-13 of the Administrative Code is being re-organized as part of the five year rule review process. This re-organization will coordinate the review cycle for all rules within the Chapter and simplify future reviews. New rule 5101:3-13-01.1 replaces, all or in part, rules 5101:3-13-01 and 5101:3-13-04. This new rule is proposed as part of the five year rule review requirements.

This rule defines the eligibility and enrollment requirements that are applicable to professional dental school clinics. Professional dental school clinics must be accredited by the Commission on Dental Accreditation (CODA) of the American Dental Association (ADA).
