

TO BE RESCINDED

5101:3-13-01 **Eligible ambulatory health care clinic provider.**

- (A) "Eligible providers" are those public or private, nonprofit or proprietary free-standing organizations designed to provide services on an outpatient basis. For purposes of the ambulatory health care clinic program, "free-standing" means that the entity is administratively and fiscally independent of an inpatient institution such as a hospital or long-term care facility. Any entity which would be eligible as a professional association of physicians, dentists, optometrists, ophthalmologists, opticians, podiatrists, or limited practitioners is not eligible as an ambulatory health care clinic provider (reference rules 5101:3-4-01, 5101:3-5-01, 5101:3-6-01, 5101:3-7-01 and 5101:3-8-01 of the Administrative Code for definitions of qualified professional associations).
- (B) As a condition for participation in the medicaid program, an ambulatory health care clinic must be in compliance with one of the standards listed in paragraphs (B)(1) to (B)(4) of this rule. Paragraphs (B)(1) to (B)(4) of this rule constitute the four different standards adopted by the department to assure that medical or remedial care and services provided to recipients of medical assistance are of high quality. A clinic which meets one or more of the four standards is eligible to participate in the medicaid program and to receive reimbursement for those covered medicaid services rendered within the scope of the program recognized under paragraphs (B)(1) to (B)(4) of this rule.
- (1) The act of compliance with one of the programs listed in paragraphs (B)(1)(a) to (B)(1)(h) of this rule enables a clinic to be recognized for services rendered within the scope of that program.
- (a) "Joint Commission of the Accreditation of Hospitals."
 - (b) "Planned Parenthood Affiliation of America."
 - (c) Ohio department of mental health certification as an outpatient mental health facility.
 - (d) Medicare certification as a rehabilitation, diagnostic, or dialysis clinic.
 - (e) "Council on Optometry Education of the American Optometric Association."
 - (f) "Council on Dental Education of the American Dental Association."

- (g) "Commission on Accreditation of Rehabilitation Facilities."
 - (h) Ohio department of health recognition as an alcoholism outpatient and after-care services program.
- (2) The legal status as a county health department, city health department, or combined health district enables a clinic to be recognized for services rendered within the scope of the service authorized by that legal status.
 - (3) The receipt of health services block grant funds under provisions of federal law (e.g., Public Law 92-35) enables a clinic to be recognized for services rendered within the scope of the programs funded by the block grant. Such programs include: community health services; preventative health and health services; alcohol, drug abuse, and mental health services; primary care; and maternal and child health services.
 - (4) Compliance with requirements of paragraphs (B)(4)(a) to (B)(4)(d) of this rule enable a clinic to be recognized for services rendered within the scope of the medicaid program which are not included in the scope of the programs identified in paragraphs (B)(1) to (B)(3) of this rule.
 - (a) The clinic offers service programs which meet one or more of the standards identified in paragraphs (B)(1) to (B)(3) of this rule.
 - (b) The clinic provides documentation to the department showing that staff providing the services are employees of the clinic.
 - (c) The clinic submits documentation of current licensure, certification, or accreditation, as applicable, for staff who will provide the medical or rehabilitative service.
 - (d) The services offered by the clinic are rendered on an outpatient basis and are covered under the medicaid program as provided in rules 5101:3-13-04 and 5101:3-13-05 of the Administrative Code.
- (C) Eligibility as an ambulatory health care clinic provider begins as of the following dates:
- (1) For medicaid participating ambulatory health care centers certified by the Ohio department of health or by Title XVIII medicare as of December 31, 1982, eligibility as an ambulatory health care clinic exists through June 30, 1983.

- (2) For clinics not covered under paragraph (C)(1) of this rule and for all clinics as of July 1, 1983, the effective date of the medicaid provider agreement is the date of application or the date on which the conditions specified in paragraphs (B)(1) to (B)(4) of this rule, as applicable, are met, whichever is later. Services rendered prior to the effective date of a provider agreement are not reimbursable.
- (D) Eligible providers are subject to other program requirements applicable to any medicaid provider as enumerated in Chapter 5101:3-1 of the Administrative Code.
