deleted. This rule outlines the screening components that providers of Healthchek, Ohio's early and periodic screening, diagnosis, and treatment (EPSDT), shall complete as part of initial and periodic healthchek screening visits.

This proposed rule will decrease expenditures in the agency's projected budget during the current biennium. Currently, when the health education and counseling component of the Healthchek (EPSDT) screening visit lasts approximately thirty minutes or more, additional reimbursement is available. This current practice is not consistent with Current Procedural Terminology (CPT), which states that preventive medicine service visits include counseling/anticipatory guidance/risk factor reduction interventions which are provided at the time of the initial or periodic comprehensive preventive medicine visit.
