This rule is being proposed for amendment to not provide for an inpatient inflationary update for CY 2010 and CY 2011. Instead, pursuant to Am. Sub. H. B. 1, 128th General Assembly, the rule provides for a fixed five percent increase to the rates in effect on September 30, 2009 for discharges occurring between October 1, 2009 and June 30, 2011. The rule is also being amended to address the period after the expiration of the Am. Sub. H.B. 1 increase, to revert to a zero percent composite inflation factor and for five year rule review.

Rule 5101:3-2-07.4 entitled "Basic methodology for determining prospective payment rates" describes the methodology for determining prospective payment rates for inpatient hospital services and sets the annual inflationary update. Paragraph (G)(2) of this rule is being amended to adjust the composite inflation factor for CY 2010 and CY 2011 to a factor of 0.00 and to provide for a one-time 5.0 percent increase effective for discharges occurring between October 1, 2009 and June 30, 2011.
