This rule is being proposed for amendment to update the assessment rates that fund the Hospital Care Assurance Program (HCAP) for the 2008 program year.

This rule sets forth the assessment rates for the Hospital Care Assurance Program.

The amendment updates paragraph (B)(2) to establish an assessment rate of 0.01044 of a hospital's adjusted total facility costs up to \$216,373,500 and 0.008273 for any amount in excess of \$216,373,500

Total program assessment revenues are approximately \$210,522,010 for program year 2008. This is a decrease of approximately \$11 million due to the increase in Ohio's Federal Medical Assistance Percentage. These funds will be used to make Disproportionate Share Hospital (DSH) payments to Ohio hospitals through rule 5101:3-2-09.

This rule requires hospitals to pay an assessment of 0.01044 of their adjusted total facility costs up to \$216,373,500 and 0.008273 for any amount in excess of \$216,373,500. Hospitals will be required to pay approximately \$11 million less than was needed to fund HCAP 2007, due to the increase in the Federal Medical Assistance Percentage rate.

All hospitals, including those owned by counties, townships or municipal corporations, are required to pay an assessment in rule 5101:3-2-08.1, which is used to make disproportionate share payments to Ohio hospitals through rule 5101:3-2-09. Total program assessment revenues for the 2008 program year are approximately \$210,522,010. Of this amount, the department estimates that \$32,490,377 will be paid by hospitals owned by counties, townships or municipal corporations. This a decrease from program year 2007 of approximately \$11 million, for all hospitals, due to the increase in the FMAP rate.

The cost of the assessment is dependent on a hospital's adjusted total facility costs as stated above.

6. Please provide a written explanation of the agency's and the local government's ability to pay for the new requirements imposed by the proposed rule.

The assessment is used to fund the state share of disproportionate share payments to Ohio hospitals, according to rule 5101:3-2-09. The total disproportionate share payments to Ohio hospitals include federal funding in addition to the state match. In aggregate, the disproportionate share funding paid to the hospitals exceeds the assessment, although each individual hospital's disproportionate share payment is based on its cost report data as applied in rule 510:3-2-09.

7. Please provide a statement on the proposed rule's impact on economic development.

The assessment enables Ohio Medicaid to draw down federal dollars to fund the disproportionate share program for Ohio hospitals, and the additional funding has a positive effect on economic development.
