The proposed distribution formula is updated to reflect more current hospital data, to adjust the methodology used to calculate Medicaid managed care shortfall to use actual Medicaid managed care payment, and to remove the fixed Disproportionate Share Limit pool multiplier and replace it with a series of steps describing the calculation of the multiplier.

Federal funding for the Disproportionate Share Hospital (DSH) program is \$325.8 million. The state share of this expenditure, which is \$210.2 million, is funded through an assessment to Ohio hospitals referenced in rule 5101:3-2-08.1.

Total program expenditures are approximately \$536 million for program year 2008. This is a decrease from program year 2007 levels by approximately \$11.9 million due to a change in the federal match rate.
