The proposed changes implement an annual update to delete from and add to the HCPCS codes listed in appendices C, F, and G of the rule to be consistent with federal industry standards. Changes also clarify certain vision and observation codes in the rule.

The rule was changed to delete obsolete HCPCS codes and add new codes listed in appendices C, F, and G of the rule to be consistent with the CPT-2004 coding manual, which is the industry standard . The amendment also extends to April 4, 2004 the use of CPT vision codes 92004 and 92014 as described in paragraph (B)(3) of the rule and adds new CPT code 59897 as an unlisted surgery code in paragraph (F)(2)(a) of the rule. The amendment also clarifies the use of existing observation codes.
