This rule is being proposed to implement the outpatient rate increase for general hospitals that are not children's hospitals as required by Am. Sub. HB 95, and to make other amendments required by the Health Insurance Portability and Accountability Act (HIPAA).

then summarize the content of the rule:

This rule describes the outpatient payment rates and policies for hospitals that are subject to DRG prospective payment. This rule is being proposed to implement on a permanent basis the outpatient rate increase for general hospitals that are not children's hospitals as required by Am. Sub. HB 95. Specifically, the increase will be implemented by increasing the outpatient surgery rates paid to general hospitals that are not children's hospitals. This rule is also being proposed to make amendments required by HIPAA. Specifically, for services provided on or after October 16, the rule is being amended to clarify that the appropriate occurrence code is still required on claims billed for canceled surgeries and Appendices D and F of the rule were amended to clarify policies and codes provided to replace local-level codes that were eliminated under HIPAA.

This rule is being re-filed so that the elimination of old vision codes (listed in

Appendix A) and the addition of new vision codes (listed in Appendix F) for hospital billing are done at the same time as the changes in these codes billed by other providers of vision services. That way the codes the hospitals use to bill for these services will continue to be the same as the codes other providers are using to bill for these services. These changes in the effective dates are also reflected in paragraph (B)(3) of the rule.

In addition, a procedure code in appendix C was moved so that it would be listed in numerical order.

The amendment increases payments for outpatient services to general hospitals that are not children's hospitals. This estimate is based on expenditures over the 2004-2005 bienniem, as required by Am. Sub. HB 95, and includes total funds (state and federal share).

This amendment is implementing the money alloted by Am. Sub. HB 95 for the 2004-2005 budget to be paid to general hospitals that are not children's hospitals through higher rates paid for outpatient services. This amendment will result in increased payments for outpatient services to general hospitals, that are not children's hospitals, by \$19.6 million over the 2004-2005 biennium. This estimate is based on analysis performed by the Department using hospital cost report and outpatient claims data. Additionally, the Department worked with the hospital industry to gather input regarding implementation of the hospital outpatient rate increase required by the budget.
