To implement provisions of RC 5111.16, as adopted under Am. Sub. H.B. 153, 129th G.A. and section 309.30.53 of Am. Sub. H.B. 153, 129th G.A., relating to administration of the Medicaid managed care program.

This rule sets forth the eligibility and membership provisions for Medicaid managed care plans (MCPs).

The rule has been revised to change the groups eligible for Medicaid MCP enrollment, remove the option delaying the effective date of MCP coverage for persons hospitalized on their effective date of coverage, and update the prohibitions against discrimination. Additionally, updates were included to change the department's name from the "Ohio Department of Job and Family Services (ODJFS)" to the "Ohio Department of Medicaid (ODM)."
